

# SUMMARY ANNUAL REPORT FOR

## LOCAL 21 WELFARE FUND

THIS IS A SUMMARY OF THE ANNUAL REPORT FOR THE LOCAL 21 WELFARE FUND, (EMPLOYER IDENTIFICATION NO. \*\*\_\*\*\*7983, PLAN NO. 501) FOR THE PERIOD JULY 1, 2021 TO JUNE 30, 2022. THE ANNUAL REPORT HAS BEEN FILED WITH THE EMPLOYEE BENEFITS SECURITY ADMINISTRATION, AS REQUIRED UNDER THE EMPLOYEE RETIREMENT INCOME SECURITY ACT OF 1974 (ERISA).

### INSURANCE INFORMATION

THE PLAN HAS CONTRACTS WITH MUTUAL OF OMAHA INSURANCE COMPANY, EMPIRE BLUE CROSS BLUE SHIELD RETIREE SOLUTIONS, EMPIRE HEALTH CHOICE ASSURANCE, INC., AND COMPANION LIFE INSURANCE COMPANY TO PAY THE FOLLOWING TYPES OF CLAIMS INCURRED UNDER THE TERMS OF THE PLAN.

ALL LIFE INSURANCE, ACCIDENTAL DEATH & DISMEMBERMENT, HEALTH INSURANCE, PPO CLAIMS

THE TOTAL PREMIUMS PAID FOR THE PLAN YEAR BEGINNING JULY 1, 2021 AND ENDING JUNE 30, 2022 WERE \$2,342,552.

THE VALUE OF PLAN ASSETS, AFTER SUBTRACTING LIABILITIES OF THE PLAN, WAS \$14,156,269 AS OF JUNE 30, 2022 COMPARE TO \$15,832,372 AS OF JULY 1, 2021. DURING THE PLAN YEAR THE PLAN EXPERIENCED A DECREASE IN ITS NET ASSETS OF \$1,676,103. THIS DECREASE INCLUDES UNREALIZED APPRECIATION OR DEPRECIATION IN THE VALUE OF THE PLAN ASSETS; THAT IS, THE DIFFERENCE BETWEEN THE VALUE OF THE PLAN'S ASSETS AT THE END OF THE YEAR AND THE VALUE OF THE ASSETS AT THE BEGINNING OF THE YEAR, OR THE COST OF ASSETS ACQUIRED DURING THE YEAR. DURING THE PLAN YEAR, THE PLAN HAD TOTAL INCOME OF \$16,045,493. THIS INCOME INCLUDED EMPLOYER CONTRIBUTIONS OF \$15,172,258, EMPLOYEE CONTRIBUTIONS OF \$1,161,543, REALIZED LOSSES OF \$171,363 FROM THE SALE OF ASSETS AND EARNINGS FROM INVESTMENTS OF \$-543,106. PLAN EXPENSES WERE \$17,721,596. THESE EXPENSES INCLUDED \$1,102,847 IN ADMINISTRATIVE EXPENSES AND \$16,618,749 IN BENEFITS PAID TO PARTICIPANTS AND BENEFICIARIES.
